The US also gave a total of \$18.6 billion of equipment to the Afghan National Defense and Security Forces from 2005 to August 2021, according to CNN. During the Soviet-Afghan War, the Mujahideen obtained weapons from many sources, mostly supplied by foreign sources, such as the Central Intelligence Agency's Operation Cyclone, China, Egypt, Iran, and the United Kingdom, and channeled through Pakistan. According to various sources, Afghanistan has also received weapons and military equipment from Pakistan, Russia, and other countries.

Commentary

The US military also had a significant presence in Afghanistan and provided various types of military equipment to the Afghan security forces. However, the US military began to destroy and remove its equipment from Afghanistan after the signing of the Doha Agreement in February 2020.² The agreement memorialized the United States' commitment to withdraw its forces from Afghanistan and required the Taliban to prevent any group or individual from using Afghan soil to threaten the security of the United States and its allies.³

Despite claims by some media outlets and politicians, the US did not gift the Taliban \$80 billion in weapons.⁴ According to a fact-check by USA Today, the US spent \$28 billion on equipment, including aircraft, vehicles, and other military hardware, that was either destroyed, transferred to the Afghan security forces, or left behind during the withdrawal.³

There have been concerns about the fate of the military equipment left behind in Afghanistan after the withdrawal. NBC News reports that much of the equipment was lost in combat or retired from service, and a significant portion of US military aid, particularly small arms, has ended up in the wrong hands in the past.⁵

In conclusion, the supply of arms to Afghanistan from 1970 to 2023 has been a complex and multifaceted issue involving various actors and factors. While the US and other countries provided military equipment to the Afghan security forces, the fate of this equipment after the withdrawal has raised concerns about its potential misuse.
